## PRIORITIZING ORAL HEALTH ADVOCACY

### Students Seize Opportunity to Push for Change in Albany and DC

Behind the oral healthcare provided in operatories, emergency rooms and mobile clinics around the country are the conversations taking place in conference rooms and chambers at the local, regional and national levels.

Like the mouth is the gateway to the body, its health closely intertwined with a person's overall well-being, making these visits, connections and cases are crucial to the health of dentistry and the communities they serve.

Stony Brook students have been on the front line of such efforts in recent months, traveling to the New York State Capitol, as well as the United States Capitol, to advocate for oral healthcare initiatives benefiting not just patients but entire communities, as well as the more than 40,000 dental professionals practicing in New York State. The experiences have been an introduction to the key people, places and methods.

"Advocacy at the state and national level is critical for advancing oral healthcare," said Patrick Lloyd, dean of Stony Brook School of Dental Medicine. "In partnering with organized dentistry to champion policies that expand access and promote preventive care, we can help transform communities and ensure every patient receives the care they deserve."

The New York State Dental Association (NYSDA) hosted in-person advocacy events over the winter and spring that focused on three topics: workforce, dental insurance reform and access to care.

Advocacy is a two-way street. To better understand bills that are proposed, Lloyd said that legislators appointed to key roles on health and education committees are eager to gather information from those in the profession, including dental school personnel. Visits from institutions like Stony Brook help familiarize lawmakers with, among other subjects, how schools can contribute to a more favorable distribution of dental providers in New York State. In turn, such interactions can train students on the nuances of advocacy and inspire them to become lifelong oral healthcare ambassadors.

New York State Assemblywoman Carrie Woerner has long made community health a priority, especially for underserved populations, proposing legislation ranging from improving broadband internet coverage to facilitating access to affordable, nutritious foods in rural and urban supermarkets. She, too, is concerned with the dearth of dentists in Dental Health Professional Shortage Areas (DHPSA); over 40 percent of counties in

New York are full or partial DHPSAs. Woerner has thus backed bills aimed at, among other topics, expanding loan relief to dentists and making purchases of oral hygiene products tax-exempt.

“The best predictor of good health throughout your life, and into old age, is how well you care for your teeth, and how much care you get from the dentists in our communities,” Assemblywoman Woerner said in a media address in March. “What I’ve also learned is we have a critical shortage of dentists, particularly in our poorer and rural communities. We need to fix that problem.”

Stony Brook is supporting these bills at home through such financial aid opportunities as the Dean’s Scholarship Fund for Underrepresented Students and the Drs. Richard and Mary Truhlar Endowed Scholarship. Stony Brook has made a point to recruit students from upstate New York, helping to address shortages seen in underserved areas.

Anthony Monaco, DDS ’25, who joined Lloyd and second-year dental student Christina Chalmers on

the Albany visit, was one of the inaugural recipients of the Dean’s Scholarship. For him, advocacy efforts are personal. He grew up in Laurens, New York, a town of about 2,400 people in Otsego County, where dental services are limited, and specialty dental care often requires driving upward of two hours for care. It’s an inconvenience for some, and a non-starter for others, who may not have the money or time to make the trip. To help address the healthcare disparity, Monaco expects to return to central New York to provide care in or near his hometown after he completes his general practice residency at NewYork-Presbyterian Brooklyn Methodist Hospital.

“Having grown up in a rural community, I have witnessed firsthand the impact that limited access to care can have on individuals and families,” Monaco said. “Given that many New Yorkers lack a dental home, it is imperative that state leadership and its institutions take active steps to address unmet oral

health needs. Drawing from our training and patient care experiences, our group offered well-informed perspectives to help guide policymakers in a direction that promotes equitable access to dental care.”

In addition to state politicians, the Stony Brook contingent met with NYSDA members, and partnered with them in conversations with legislators. These partnerships, said Lloyd, are vital in advancing initiatives that may eventually benefit the public and the profession.

“Learning from and partnering with organizations like NYSDA and the American Dental Association only help to amplify our voice in advocating for oral healthcare for positive change,” he said.

Advocacy, though, doesn’t stop at the state’s boundaries. To learn further about oral healthcare issues and policies at a national level, 10 Stony Brook dental students accompanied Lloyd to Washington, DC,

for the ADA's annual Dentist and Student Advocacy Day. Topics ranged from community water fluoridation and student loan reform to proposed bills such as the Dental and Optometric Care (DOC) Access Act, which is aimed at regulating anti-competitive practices by dental and vision insurance companies, restoring control to patients and providers. The Stony Brook collective met with New York legislators who convey their interests to a broader audience.

Chalmers connected with Congressman Nick LaLota inside the US Capitol building concerning topics including water fluoridation and the Resident Education Deferred Interest (REDI) Act, which has garnered bipartisan support from healthcare organizations, including the ADA. The bill would allow postgraduate students to earn interest-free deferment on their student loans during residency.

“It was an incredibly rewarding experience that showed how students can play a role in shaping the future of our profession and the quality of patient care,” Chalmers said. “Having the opportunity to speak with Representative LaLota offered a new perspective in support of the REDI Act — that of the dental student. Many of us have taken significant student loan debt to finance our education, and the REDI Act would offer us the opportunity to pause interest accrual, so we do not continue to accumulate debt while completing a specialty program. This would relieve a major financial burden and encourage more dentists to pursue careers in community health and research.”

The experience proved meaningful for her and her classmates — and by keeping these conversations going, the ripple effects could lead to lasting improvements in both patient care and the profession at large.

ADVOCATING FOR BRIGHTER SMILES

Advocacy in dentistry is a powerful force for driving change — within our communities, the healthcare system, and in improving access to oral healthcare. By extending beyond the clinical aspects of dentistry, dental professionals can shape the future of the profession and improve access to essential oral health care needs.

Advocacy isn't just limited to professionals; dental students, too, play an important role. From advocating for changes in student loan repayment to contributing new perspectives to longstanding challenges, students are helping to lead conversations that will impact future dental care. As students attending a state university, there is increased responsibility for us to advocate for expanded care for underserved populations across the state.

This March, I joined thousands of dentists and dental students in Washington, DC, to advocate on behalf of patients and fellow students. My classmates and I met with lawmakers, and discussed issues impacting dentistry. At the Capitol Building, I spoke with US Representative Nick LaLota about several pressing topics, including the importance of promoting community water fluoridation and increasing NIH funding for fluoride research to address misconceptions about its safety. I was able to express

my support for the Resident Education Deferred Interest Act (REDI), which would allow dental residents to qualify for an interest free deferment of student loan payments while completing their residency program. I explained how this legislation could encourage dental students to participate in research or serve in underserved communities by helping to alleviate the financial burden of student loan debt.

Motivated by the impact we could make, I later traveled to Albany to participate in the NYSDA Access to Care Advocacy event. There, I met with state senators, including Senator Rivera and Senator Gallivan, to discuss initiatives aimed at expanding access to care in New York State. One proposal involved expanding the scope of practice for dental hygienists by allowing them to administer block anesthesia. This would allow dentists to focus on complex care and improve workflow. Another initiative advocated for permitting dentists to administer the HPV vaccine and in emergency situations, the COVID-19 and influenza vaccinations.

To be involved in efforts to improve the future of dentistry has been an extremely rewarding experience and has emphasized the importance of organized action and using our voices to shape the profession and patient care. I encourage all dental students to get involved with advocacy efforts to help create a longstanding impact on the healthcare system within our communities.

## CLASS OF 2025 SMILES EAR TO EAR AT CONVOCATION CEREMONY

Pride and joy brimmed and — fittingly — smiles stretched from ear to ear as Stony Brook School of Dental Medicine's Class of 2025 proudly crossed the stage to receive their dental school degrees and advanced degree certificates at the annual convocation ceremony held at Stony Brook University's Staller Center for the Arts.

The school's newest dentists, 47 Doctor of Dental Surgery (DDS) graduates will now continue their residency training in areas including general dentistry, oral and maxillofacial surgery, orthodontics, pediatric dentistry, periodontics and prosthodontics. Additionally, 37 residents, one doctoral student and one master's degree student were feted by the event's more than 500 attendees.

Patrick Lloyd, dean of the School of Dental Medicine, acknowledged the lasting impact the class has had at Stony Brook, having brought distinct personalities, life experiences and varied educational backgrounds to the school.

"Thank you for helping shape our school," he said. "You've left a mark on it that will benefit those who follow for years and years to come. And for that we are truly grateful."

His address was followed by that of Class President Dana Lee, DDS '25, who encouraged her peers to take a moment to reflect on their incredible achievement, and the path they took to arrive at their goal.

"We didn't just survive dental school. We thrived. We persevered," Lee said. "We grew into clinicians, advocates and caregivers in the truest sense of the word. And through every challenge — every practical, every patient, every setback — we showed up, with grit and grace.

"It's easy to forget what we've actually accomplished after the whirlwind has died down, to forget how extraordinary it is to get here," she continued. "So before we rush off into residencies, practices, or well-deserved vacations — take a second to breathe this in. Let the weight of this moment settle in your chest. You took the road less traveled, and getting here, to this moment, was no small task. You deserve it. You've earned it."

Lee, like more than 30 of her classmates, began residency this summer in New York State. The SDM's newest alumni joined programs in 10 other states, including California, Florida, Maine, Maryland,

Massachusetts, New Jersey, Ohio, Pennsylvania, Texas and Virginia. At graduation, Vito Liut, DDS '25, soaked in the moment before heading off to his prosthodontics residency with the United States Dental Corps at the Walter Reed National Military Medical Center in Bethesda, Maryland.

"Everything will probably kick in for me in a couple days," Liut said. "There were a lot of challenges, tears and happiness in dental school, but I'm glad I went through it, especially with my classmates. I would definitely do it again. It was worth it."

From graduation, Aditya Mehra, DDS '25, continued his career as a general practice resident at the Veterans Affairs (VA) Medical Center in Boston, Massachusetts. He called convocation “a beautiful experience” but also acknowledged that the moment was bittersweet.

“It’s been really nice to celebrate with my classmates, who I’m going to miss,” Mehra said. “Dental school was definitely daunting at first, but the four years went by really quickly. It all came together in the end. I’m thankful for everybody who was there to help me throughout the way. I couldn’t have done it without the faculty, my friends and my family.”

They included Arielle Adams, DDS '25, who came to Stony Brook after started her career in oral healthcare as a dental hygienist. With two of her dental school classmates, Adams recently started her general practice residency at the VA Medical Center in Buffalo, New York,

not far from where she grew up.

“It feels fantastic,” Adams said. “Many years of hard work were put into this, and I give thanks to my family and friends. We made it. I’m so grateful.”

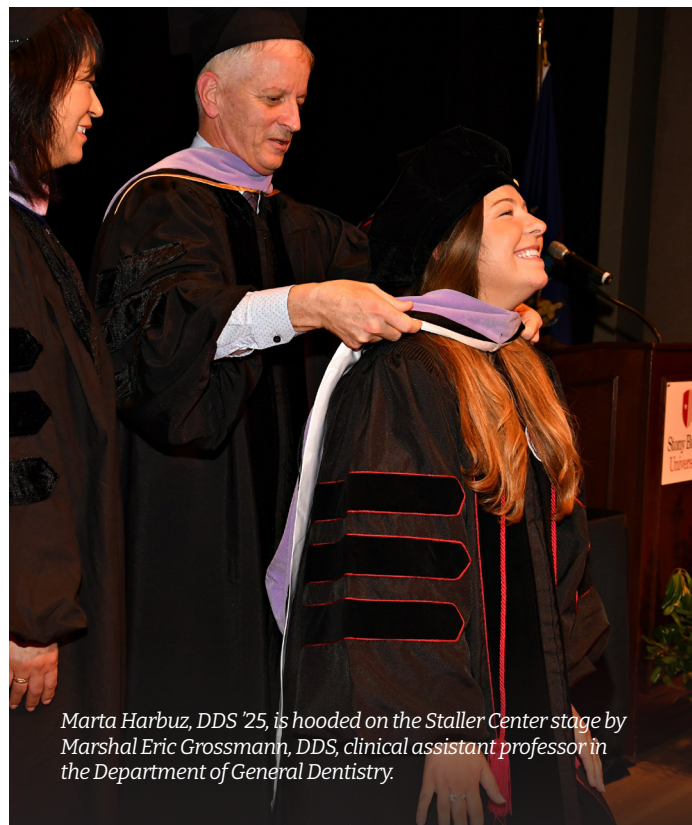
Like with the DDS class, residents and graduate students crossed the stage to great applause. Among them was Kyle Reeves, DDS, OMFR '25, who owned and operated a private practice in Texas for more than 20 years before coming to Stony Brook to complete an oral and maxillofacial radiology residency. His son, daughter-in-law and 2-year-old granddaughter flew in to celebrate at convocation, after which Reeves returned to Texas to split his duties between an oral and maxillofacial radiology private practice as well as teaching part-time in Dallas and Houston.

“I’m thankful for the opportunity to be able to pursue a Plan B in my career,” Reeves said. “Being in private practice and coming back into an academic institution, it was humbling to have to learn and relearn some things. I had an excellent experience at Stony Brook, and the time I got to spend with my co-residents, and with Dr. [Mina] Mahdian and Dr. [Dan] Colosi, has been very rewarding.”

The afternoon’s keynote address was delivered by Canise Bean, DMD, MPH, professor emeritus at The Ohio State University College of Dentistry and a leader in helping to deliver oral healthcare services to underserved areas in Ohio. Bean served as the director of community education at OSU for more than 20 years, overseeing the Oral Health Improvement through Outreach (OHIO) Project, a mobile dental coach that cared for children in Columbus City Schools as well as 27 other community-based sites.

Bean implored the Class of 2025 to allow their passions and values to serve as beacons throughout their careers, and to continue to learn, mentor, innovate and give back.

“The road is yours to shape,” she said. “You’re stepping into a world of tremendous opportunity, and you’re entering a profession that has the power to change lives. Not only are you dental professionals, but keep in mind that you are healers, you are educators, you are innovators and you are advocates.”

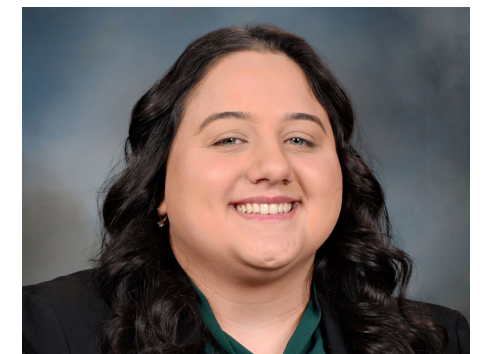

## WHITE COATS FIT JUST RIGHT

*The Class of 2028 pledged their commitment to dentistry at their White Coat Ceremony in May.*

In front of family and friends, 46 first-year students at Stony Brook School of Dental Medicine's Class of 2028 pledged their commitment to excellence and ethics in patient care at the annual White Coat Ceremony, held at the Sidney Gelber Auditorium on Stony Brook University's main campus.

Eighty-seven percent of the class hails from New York State, a promising figure given the school's commitment to build up the dentistry workforce, particularly in Dental Health Professional Shortage Areas (DHPSAs). They came to the SDM from 23 undergraduate institutions, including 11 who earned their bachelor's degree at Stony Brook University.

The white coats symbolizing their dedication to the well-being of their patients, the Class of 2028

will begin seeing patients in the Dental Care Center (DCC) in the spring of their first year before seeing a full complement of patients at the beginning of their second year, a clinical setup unique on the dental school landscape.

"We, your faculty, look forward to deepening your knowledge, refining your values, and teaching you skills over the next three years so that you will be prepared to bear the title of doctor," said Dolores Cannella, MA, PhD, associate dean for education and associate professor in the Department of General Dentistry. "But we are not your only teachers. Your patients will indeed teach you as well. Remember to be astute observers and listeners to your patients, who will teach you how to reach a proper diagnosis, how to deliver patient-centered care

and how to improve patient lives."

Brian Howe, DMD, MS, associate dean for clinical operations and patient care in the DCC and associate professor in the Department of General Dentistry, shared helpful "pearls" that he has accumulated in his years of practice, hallmark by compassion, compromise and commitment to continuous improvement. Also, he recommended that they take advantage of emerging technology in the field but

not lose sight of what's most important in caring for patients.

"Remember the impact that you have on each patient you see. Remember, it is about the person you are treating," Howe said. "Technology is a great tool that allows us to provide amazing dentistry, but keep in mind that dentistry isn't about the gadgets and the wow factor. It is about taking care of people and the impact that you will have on their lives."

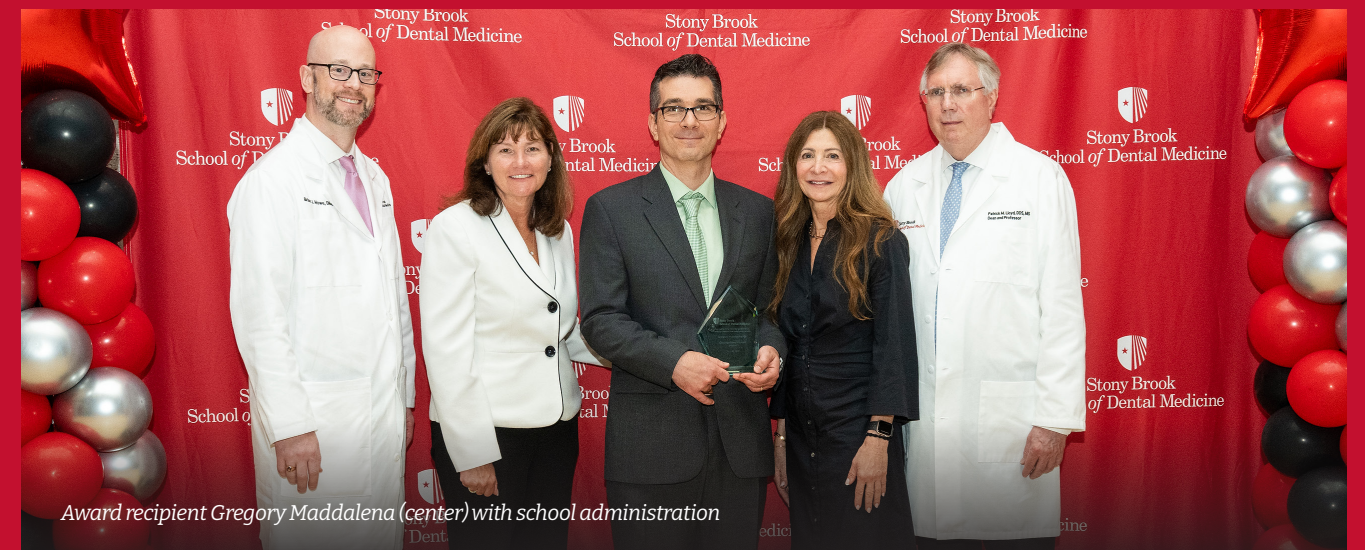
## MADDALENA NAMED 2025 DISTINGUISHED ALUMNUS

Gregory Maddalena, DDS '05, GPR '06, chief dental officer for Sun River Health in New Paltz, New York, the largest network of oral health Federally Qualified Health Centers (FQHC) in the state, is the 2025 recipient of the School of Dental Medicine's Distinguished Alumni Award.

Since graduating with his DDS degree, Maddalena went on to private practice in New York and New Hampshire, and much of his service has centered around providing care for underserved populations, beginning with his care of farm workers on the east end of Long Island. It continued when he and his wife, Amy Angiolillo, MD '05, relocated to the Hudson Valley, where at Sun River Health he began to care for a wide range of patients, including workers at the local apple farms.

In 2020, he took over as the organization's chief dental officer, overseeing 24 dental offices throughout southeastern New York, including in his primary office in New Paltz. The majority of the patients he and his staff care for earn below the federal poverty line, yet he shared with the audience how fulfilling — and important — the service he provides.

"I am honored and humbled to receive the Distinguished Alumnus Award from Stony Brook School of Dental Medicine, which gave me a strong foundation to provide high-quality care to high-needs patients," Maddalena said. "This is so essential in New York State, where nearly half of the 62 counties face full or partial dental care shortages, disproportionately affecting vulnerable populations."

## A RANGE OF ACCOLADES

PhD student **Abdel Hameed Mahmoud, DDS**, earned first place for his research poster at the American Association of Endodontists (AAE) annual meeting in Boston, Massachusetts. Mahmoud's research, titled "An Innovative Injectable Retrievable and Sustainable Drug Delivery System for Endodontic Therapy", showcased a new thermo-reversible hydrogel that, combined with calcium hydroxide and salicylic acid, effectively eradicates *E. faecalis* biofilm, and improves intracanal delivery and retrievability in endodontic cases. His work was selected from a pool of more than 160 presenters at the specialty's largest conference. After completing his PhD at Stony Brook, Mahmoud joined the Advanced Education in General Dentistry (AEGD) program at Eastman Institute for Oral Health in Rochester, New York this summer, with designs on advancing into a career in endodontics, as a practitioner and educator.



**Byung Min Nahm, DMD, Pros '25**, captured first place in the Research Digital Poster category at the American Prosthodontic Society annual meeting in Chicago. His research examined the impact of a bone leveler on prosthetic abutment fit in subcrestal implant placement in guided implant surgery. Upon completing his tenure as chief resident in the program at Stony Brook, Nahm began his maxillofacial prosthetic fellowship at Memorial Sloan Kettering Cancer Center in New York City in July.



Third-year dental student **Astrid Bucaro** received the New York Academy of Dentistry Excellence in Research Award at the organization's event in New York City

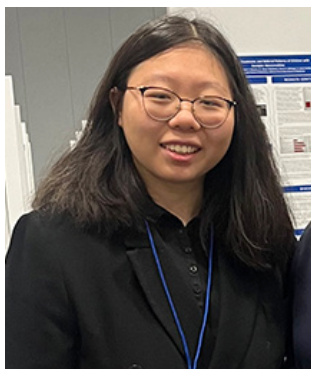
in February. Bucaro's research focused on the efficacy of 5-fluorouracil in pediatric and young adult patients with odontogenic keratocysts.

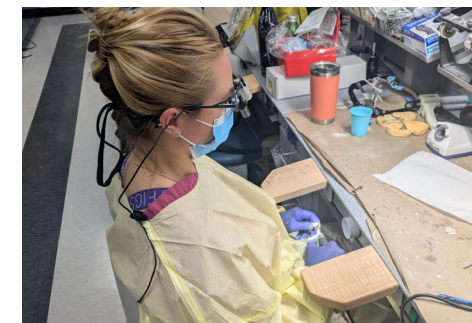

# RESEARCHERS AWARDED NIH GRANT TO EXPLORE HEART DISEASE CUES HIDDEN IN DENTAL SCANS

**M**ina Mahdian, DDS, MDSc, associate professor in the Stony Brook School of Dental Medicine Department of Prosthodontics and Digital Technology, and Prateek Prasanna, assistant professor in the Department of Biomedical Informatics, have received a \$300,000 grant from the National Institute of Dental and Craniofacial Research (NIDCR) of the National Institutes of Health (NIH) to explore whether routine dental imaging can be used to detect early signs of heart disease.

The two-year research project is titled, “Automated Characterization of Arterial Calcification in Dental Cone Beam Computed Tomography as Predictors of Cardiovascular Disease.” It aims to develop an AI-driven

tool that can automatically identify and characterize arterial calcifications, mineral deposits that can signal cardiovascular risk, visible in cone beam CT (CBCT) scans commonly used in dental practices.

“I am excited about this project, as this is the first study to apply quantitative imaging biomarkers, such as radiomics, to characterize vascular calcifications in CBCT to predict cardiovascular disease,” Mahdian said. “The majority of current AI research is focused on common dental pathologies, whereas this project signifies the role of AI in assisting dental providers with predicting the risk of cardiovascular incidents based on dental CBCTs and making proper and timely referral.”

Mahdian is a member of the Global Initiative on

Artificial Intelligence for Health, Dental Diagnostics and Digital Dentistry, a mission launched by the World Health Organization (WHO), International Telecommunication Union (ITU) and World Intellectual Property Organization (WIPO). Its aim is to improve healthcare worldwide using AI and promote the exchange of knowledge and the development of technical standards for the use of AI in the healthcare sector.

“At the IMAGINE Lab, we’re committed to pushing the boundaries of what AI can do for healthcare,

beyond traditional domains like cancer. This project is a prime example of how advanced machine learning and imaging analysis can reveal hidden signals in routine scans, like dental CBCTs, to inform risk for systemic diseases such as cardiovascular conditions,” said Prasanna, director of the Imaging Informatics for Precision Medicine (IMAGINE) Lab. “By bringing sophisticated computational tools to bear on everyday clinical data, we hope to enable earlier, more informed interventions, and showcase the broader impact AI can have across medicine.”

If successful, the technology could serve as an early warning system embedded in routine dental visits, alerting providers to possible risk factors and encouraging timely follow-up with medical professionals.

“Dr. Mahdian’s NIH award demonstrates the collaborative potential that exists when a dental school resides on a university campus and is an integral member of an academic health center. In such settings disciplines can capitalize on each other’s unique skills, technologies and clinical interpretations,” said Patrick Lloyd, dean of the School of Dental Medicine. “It is from collegial environments like ours that discoveries are made, new knowledge is created and ultimately patients are better cared for. The future of the dental profession depends on schools with what we are and have done.”

The research is supported by the National Institute of Dental and Craniofacial Research of the National Institutes of Health under Award Number R03DE033489.

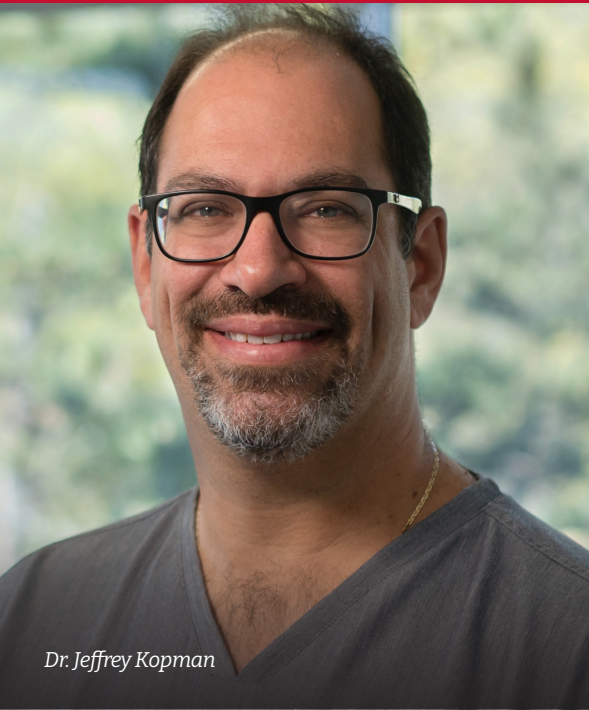

That's a great question! When I'm not in clinic rotations, I assist in the clinic van that visits schools and shelters to provide oral care and assist with translation for Spanish-speaking patients. They say, do what you love, and you won't feel like you're working. That is how this job is for me. I love it because I get to help people whether it's the patients, students or residents.

### What does societal outreach in dentistry mean to you?

This is such a passion of mine and it's why I have been in this role for so long. Being at Stony Brook has given me a chance to help treat all walks of life. When someone is anxious or doesn't understand how the procedure will go, I try my best to calm them down and provide them with the best experience they can have. ## "FOUNDATIONAL" ALUMNUS BIDS ADIEU TO SDM

Few know the halls of Stony Brook School of Dental Medicine more than Mary Truhlar, DDS '84, MS.

She navigated them first as a student, then as a member of the faculty and administration, and in many roles since and in between — leader, mentor, colleague and friend among them.

Her colleagues celebrated Truhlar's career at a special reception at the Three Village Inn in Stony Brook Village, toasting her many achievements as one of its fixtures.

Addressing those in attendance, Truhlar expressed gratitude for "the friendships and relationships we've built, the projects we've shared, the classroom and clinical experiences, the many accomplishments and, of course, the adventures along the way that added humor and levity to the situations."

Dean Lloyd opened the evening by sharing Truhlar's numerous accomplishments, before giving way to longtime faculty such as Dolores Cannella, MA, PhD, associate dean for education, who contended that Truhlar's impact on the school will last long beyond her retirement.

"Mary's legacy is woven into the very fabric of the SDM," she said. "It isn't just present—it's foundational. She helped shape the School of Dental Medicine into what it is today, and what it will become tomorrow."

Truhlar was the first female — and the only alumnus — to serve in the role of dean at Stony Brook, doing so from 2014 to 2020. In that position, she championed the funding and support for the state-of-the-art Center for Implant and Digital Technology and launched the school's oral and maxillofacial radiology residency

program. All the while, Truhlar instructed and inspired students as a professor in the Department of General Dentistry, provided care in Stony Brook's faculty practice, and advanced the profession through funded research.

"In her entire 35-year career at Stony Brook, Mary has always put the needs of faculty, students, residents, staff, and patients of the SDM above all else," said Allan Kucine, DDS, vice chair of the Department of Oral and Maxillofacial Surgery, who joined the Stony Brook faculty with Truhlar in 1990. "Her contributions to education, patient care and administration have left an indelible signature on the history of the School of Dental Medicine."

Among those who shared their admiration was Ying Gu, MS, DDS '02, PhD '02, AEGD '03, who first encountered Truhlar as a PhD student in the 1990s. Since then, Gu has learned from Truhlar as a dental student, general dentistry resident, faculty member in the Department of General Dentistry, and now as its chair.

"As clinicians, we can directly improve the oral health of a limited number of patients, but as educators, we have the power to improve the health of many more," Gu said. "Dr. Truhlar has devoted her entire career to educating dental students and advancing the dental profession. She has shaped the paths of so many of us here—her influence is profound, and her legacy will continue to inspire generations of future dentists and enrich our profession for years to come."

"There is a Chinese saying: A teacher for a day is a teacher for a lifetime," she continued. "Thank you, Dr. Truhlar, for being my teacher and a great mentor."

Most recently, Truhlar created an endowed scholarship for students from Dental Health Professional Shortage Areas (DHPSA), strengthening the school's commitment to educating those from underserved areas so that they may return to these communities to provide much-needed care.

Her students, and the oral healthcare they will provide to their future patients, were always a priority during her time at Stony Brook. A preview of her farewell reception, the Class of 2027 surprised Truhlar with a celebration at the school, an occasion that included a one-of-a-kind cake created by student Eva Aminova. Truhlar promised to be back on campus for their graduation, when they, like her, can call themselves proud Stony Brook alumni.

## IN MEMORIAM

**Martin Stern, DDS**, professor and founding chair of the Department of Oral and Maxillofacial Surgery, passed away at the age of 91.

Stern played an integral role in the growth and development of the school, having served from its opening in 1973 through his retirement from academia and dentistry in 1993. During his time, he was responsible for the construction of the curriculum, the appointment of several longtime faculty members, and the education of hundreds of School of Dental Medicine graduates.

While at Stony Brook, Stern concurrently worked as an oral and maxillofacial surgeon at three hospitals, including as chief of oral and maxillofacial surgery at Queens General Hospital and Long Island Jewish (LIJ) Medical Center, at which he also directed of the training program in oral and maxillofacial surgery. His efforts paved the way for LIJ residents to rotate through the SDM and Stony Brook University Hospital.

Dr. Stern made a lifelong impression on students, residents, staff and faculty, including Anthony Casino, DDS '78, clinical associate professor in the OMFS department, who called Dr. Stern "the ultimate administrator" as well as a "mentor to many and a friend to all."



**Mark Swerdloff, DDS**, professor emeritus of oral and maxillofacial surgery and a faculty member for more than 35 years, passed away on April 18, 2025, at the age of 80.

Swerdloff overcame great adversity to become a highly regarded surgeon, educator and mentor to students, residents, staff and faculty alike. As a second-year dental student at Columbia University School of Dental and Oral Surgery, he was struck by a vehicle, resulting in the loss of both of his legs. Swerdloff nevertheless persevered, earning his DDS from Columbia and completing his oral and maxillofacial surgery residency at Mount Sinai Hospital in New York City.

In 1975, Swerdloff was appointed as the first full-time faculty member in the SDM's Department of Oral and Maxillofacial Surgery. He served in this position until 2007, during which time he was awarded the Stony Brook President's Award for Excellence in Teaching. Swerdloff taught for an additional five years on a part-time basis. In addition to his academic appointment, he cared for patients at the Dental Care Center, Stony Brook University Hospital as well as at the Northport Veterans Affairs Medical Center.

# SIDE BY SIDE FROM THE START

Little did Tamara Kroboth, BS '04, DDS '08, Ortho '11, and Alex Bogler, BS '04, DDS '08, GPR '09, know that years after their journey through the School of Dental Medicine, even more years since meeting as undergraduates at Stony Brook University, they would be practicing — and going through life — side by side. Together, they care for patients at Valley Pediatric Dentistry and Orthodontics, a practice with locations in Jefferson Valley and Hopewell Junction, New York, joining up with another Stony Brook graduate, founder and chief executive officer Ben Dancygier, DDS '96. *On the Cusp*® caught up with the couple to learn about what happens when career paths — and personal lives — converge.

*We should start at the beginning. How did you meet?*

**Kroboth:** We first met during our freshman year at Stony Brook University in the Honors College. Alex had transferred from Fordham after his first semester and joined the Honors College in the spring. During his first week, he was looking to introduce himself to our classmates and was going door to door in the Honors College dorm, Cardozo. When he knocked on my friend's door, I happened to answer. Clearly flustered, Alex asked for information about applying to live in the dorms. Wanting to help, I took him to the main office and gave him several brochures. We went on our first date about a week later.

*How would you describe your Stony Brook experience?*

**Bogler:** I believe the education and training I received at Stony Brook — both in dental school and during my residency — provided a strong foundation that thoroughly prepared me for the transition into private practice. During my GPR at Stony Brook, I was able to focus on implant dentistry and prosthodontics, which has enabled me to confidently manage more complex cases, while also giving me the clinical judgment to recognize my limitations and refer patients to specialists when appropriate.

*You had surgery/orthodontics done while you were a student at Stony Brook. What was that like?*

**Kroboth:** I did not have the opportunity to undergo orthodontic treatment as a child. However, once I began dental school at Stony Brook, straightening my teeth became a top priority. Entering the dental

profession, I recognized the importance of presenting my best self and feeling confident in my smile. My treatment included braces and a surgically assisted palatal expansion. The surgery itself was relatively straightforward; the greater challenge was adjusting to the palate expander as an adult. Throughout my treatment, I spent a significant amount of time with the orthodontic residents, and that experience played a pivotal role in inspiring my decision to specialize in orthodontics.

*How did you come to practice together?*

**Bogler:** I owned and operated my own dental practice from 2014 to 2022. After sustaining a back injury that limited my ability to work full-time, I made the difficult decision to sell the practice. However, my passion for patient care remained strong, and I wanted to stay clinically active on a part-time basis. I approached Dr. Ben about the possibility of seeing adults and older teens at Valley Pediatric Dentistry, and it has been a smooth and rewarding transition. It's been a pleasure to join such a well-established and highly respected practice where I can continue contributing to patient care in a meaningful way.

*Dr. Kroboth, you spent two years as president of the Dutchess County Dental Society. Why have you made organized dentistry a priority?*

**Kroboth:** I have participated on the board of the Dutchess County Dental society for about a decade in various roles including steward, president and program chair. Our society is a branch of the Ninth District. The joint specialty model allows us to streamline patient care, often coordinating cleanings with orthodontic adjustments to minimize appointments and improve continuity. Dr. Ben's practice was already a thriving and well-established part of the community before the

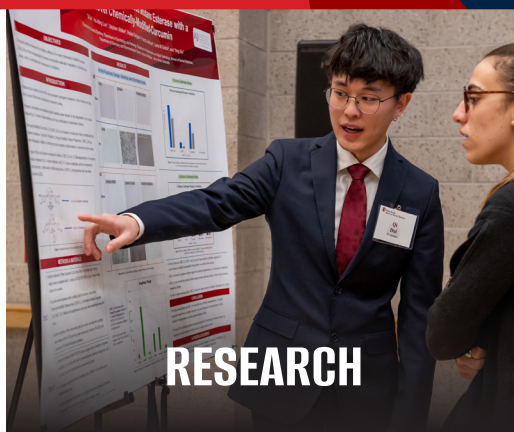
